

An unusual opportunity to purchase a good size stone built garage fronting Bristol Road on the western edge of Keynsham ideal for storage and with potential for conversion to other uses subject to necessary planning consents.

The property enjoys a prominent location within walking distance of the town centre and adjacent to the recently completed Treetops Development and bordering a public footpath to the west, Bristol Road to the north and the Treetops development to the east and south.

The garage has been panelled internally and has power and light connected. The internal measurements are $5.35m \times 4.47m (17' 6" \times 14' 7")$

PLANNING: Our clients have not made any formal approach to the local planning authority Bath and North East Somerset Council. The site is adjacent to residential properties and within the housing development boundary for Keynsham. The garage could suit a range of alternative uses subject to planning consent. It should be stressed that interested parties should make their own enquiries to the local planning authority to satisfy themselves regarding any potential and the likely hood of obtaining planning consent.

METHOD OF SALE: The property will be offered for sale by public auction (unless previously sold) the sale will take place in conjunction with Auction House Bristol and West and will be held at Ashton Gate Stadium, Winterstoke Road Bristol BS13 2LQ and will be held on Monday 11th February 2019 at 7pm.

<u>The Catalogue Details</u> of the property and land to be sold are set out in our catalogue. All lots are sold subject to Special Conditions of Sale. It is important that prospective purchasers satisfy themselves as to the location, boundaries, condition and state of the lots before the auction.

Plans, Maps and Photographs The plans, maps and photographs published on our website and in the catalogue are to aid identification of the property only. The plans are not to scale.

Energy Performance Certificates (EPCs) Where required we include EPC ratings within Full Details and on the lot page within our catalogue. When available EPC Graphs can be viewed online at bristol@auctionhouse.co.uk. <u>Guide Prices</u> Guide prices quoted online and in the catalogue are provided as an indication of each seller's minimum expectation. They are not necessarily figures which a property will sell for and may change at any time prior to the auction. The sale price will be dependent on bidding in the auction room and on the Vendors' instructions.

Reserve Price Each property will be offered subject to a reserve price which we expect will be set within the guide price range or no more than 10% above a single figure guide. This is a confidential figure set between the Vendor and the Auctioneer just prior to the auction. It is a figure below which the Auctioneer cannot sell the property during the auction. After the auction offers will be sought and considered on Unsold Lots at prices below the reserves.

<u>The Legal Aspect</u> Buying at auction is a contractual commitment. Before making an offer prior to auction or bidding at the auction it is advisable to consult a solicitor regarding the General and Special Conditions of Sale, the local authority search and other legal documentation.

Pre Auction Sales Offers made on property included in this auction catalogue may be accepted by the Vendor prior to the auction. If you are intending to bid at the auction for a specific lot, we recommend that you keep in contact with the Auctioneer's office. The Auctioneers or Vendors cannot beheld responsible for costs incurred in respect of any lot which is withdrawn or sold prior to auction.

Post Auction Sales If a property you are interested in is not sold during the auction please speak to the Auctioneer and make an offer at, above or below the Guide. Your offer will be put forward to the Vendor and if accepted, you will be able to proceed with your purchase under auction rules.

<u>Attending the Auction</u> It is always wise to allow sufficient time to get to the auction. Legal packs for most of the properties will be available for inspection. It is important you read these and the final addendum/alteration list which will also be available as any purchase will be subject to these.

<u>Bidding</u> Each property will be offered individually by the Auctioneer. Ensure that your bids are clear and noticed by the Auctioneer. If you are successful in bidding for the property you will be approached by a member of Auction House staff who will request your personal information and identification. You will then be guided to the cashiers desk for payment of the deposit.

Proof of Identification In order to abide by the money laundering regulations we ask that all prospective purchasers provide proof of identity. Please bring your passport or photographic UK driving licence and a current utility bill, bank statement or council tax bill to the auction. If purchasing on behalf of a company you will also need to present proof of your position within the company and company letterhead.

<u>Solicitors Details</u> The name, address and telephone number of the solicitor who will be acting for you in any purchase will be required before you leave the auction room.

Deposit When you buy a property you will be approached by a member of Auction House staff and asked to go to the cashiers desk to sign the Memorandum of Sale. You will be asked to pay a deposit of 10% of the purchase price subject to a minimum deposit of £3,000. Deposits can only be paid by bankers draft, building society cheque or personal cheque. Cash or card payments will not be accepted. Please note, should the cheque have to be represented, a processing charge of £50.00 + VAT will be charged by deduction from the deposit.

The Contract The Memorandum of Sale will be signed in duplicate. One copy will be given to you, which you must give to your solicitor. The second copy will be retained by the Vendors' solicitor. Completion usually takes place after 28 days but this date can vary. The legal pack of each property will state the completion date due. The date may also be announced immediately prior to the commencement of bidding of each lot.

<u>Administration Charge</u> Purchasers will be required to pay by cheque, an administration charge of 0.3% inc of VAT and minimum fee £900 inc of VAT in addition to the deposit. A VAT receipt will be issued after the auction.
